

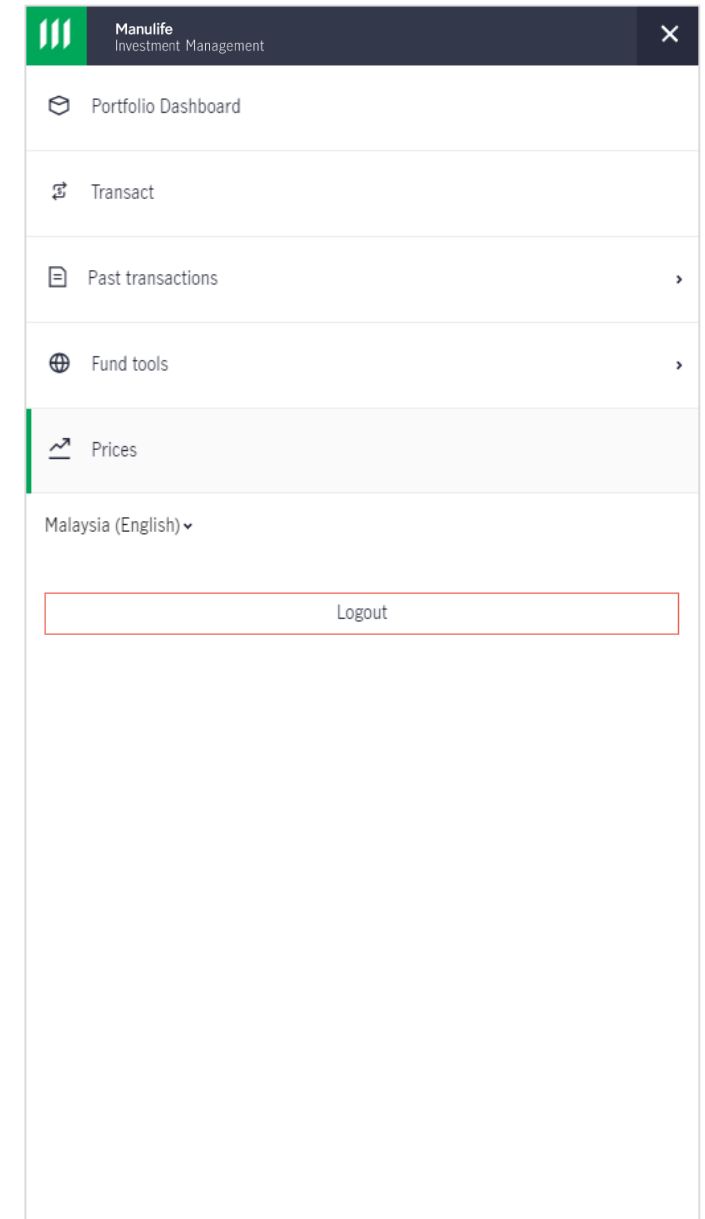

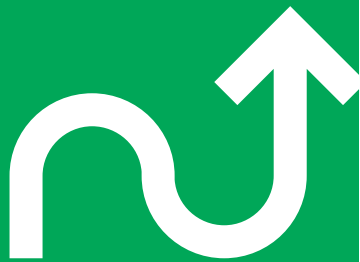

- Click on “**Subscription**” if you would like to make an investment.

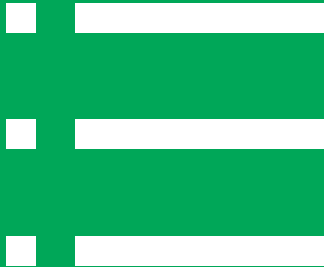

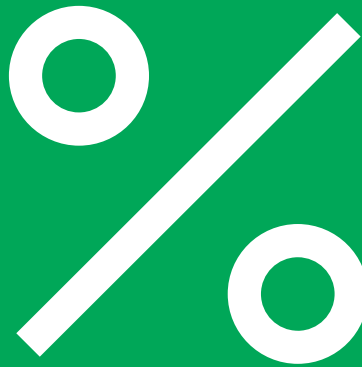
